XI. PUBLICITY

This month was a bit slim on the publicity end. We were not able to generate enough interest in the Halloween Parade to participate. The parade organizer has been notified that we will not march, and all interested members were contacted. We will try to organize a group of canine ghouls for next year's parade.

XII. OLD BUSINESS

- a. **Staples** remember to use our telephone number when making purchases, 610-439-2800. We get 10% credit.
- b. **Mats** the board is recommending we purchase new, blue ³/₄" interlocking mats to replace the current rolled mats. We would need 325 mats and three new carts at a total cost around \$7000.00. It will probably take 15-30 minutes longer to put down and take up the mats, so the cost for mat layers

will also increase. The other option is to purchase 5 new rolls of the current matting (105 ft. each) which would be taped across the center seam. Cost for mats and tape is around \$3000.00. **Discussion:** we would be the only place that will be putting down/taking up the mats, so there is some uncertainty about how they will hold up. Janice has some at home that she has taken apart and put together daily since the picnic and they are not showing any wear. It was stated by a member that we should be disregarding cost and thinking about safety. There was a discussion on how well they can be cleaned. Dog spots do not soak in or soak through the joints so they clean easily. If they are showing signs of wear, they can be flipped over as both sides are the same. Also, individual mats can be replaced if needed. A question was raised about whether the possibility of new mats had been discussed with Park Officials. They have seen the mats and are fine with storage. Estimated life span of the interlocking mats is unknown and there is no warranty. There was a question about whether the mat layers are willing to do the new mats. This will be discussed with them, but as they are new there should not be a problem. Also, the new mats a lighter and should not be as physically demanding to put down and take up. A comment was made that the current mats lay flatter now that they are on plastic rolls. Purchasing new mats will be voted on at the December meeting.

c. ADTC clothing- order was placed for polo's, hooded sweatshirts, t-shirts, jackets, and hats

Dogs + Ebola: What Every Owner Needs to Know from the American Kennel Club and the AKC Canine Health Foundation

In recent weeks, dog owners, supporters and donors have looked to the AKC Canine Health Foundation and the American Kennel Club for credible information regarding Ebola virus in dogs.

At issue is whether humans can get Ebola from dogs, and whether dogs can even get Ebola in a form that is transmittable. Due to the complexities of the virus, only time and research will answer these questions. "In humans, Ebola virus is detected using a diagnostic test for Ebola RNA. In dogs, scientists will have to establish the presence of Ebola virus RNA along with whether the virus is replication competent and infectious," said Shila Nordone, Ph.D., Chief Scientific Officer for the AKC Canine Health Foundation. "Only then will we have evidence that canine infection is a public health threat. All told, this will take many months."

Dr. J. Scott Weese, DVM, DVSc, DACVIM, a preeminent expert on infectious disease transmission in the dog, as well as the AVMA have provided the most current consensus opinions on Ebola in the dog. Over the next several months as research advances, AKC CHF and the American Kennel Club will keep the public updated on any and all progress made to better understand the role of the dog as a reservoir for the Ebola virus. 
