#### Introduction to core strengthening of the dog

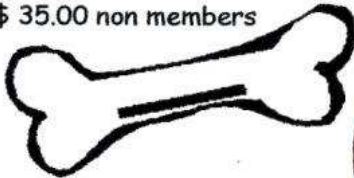
- In this introductory seminar we will learn what muscles make up the core of the dog.

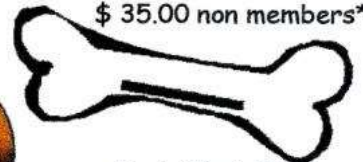
