MINUTES

Board Meeting Via Conference Call Due To Covid 19 Restrictions

The meeting was called to order at 7:22 p.m. by President Chuck Achenzie.

Roll Call

Minutes

Terry Papineau reported she received correspondence from the AKC asking clubs to follow all federal, state and local rules regarding Covid 19.

Federation Report

Edie Rysdyk reported the Federation was holding their meeting this same night and she is unable to attend it as she is attending this meeting. She also noted the Federation has put everything on hold.

Phyllis Broderick presented her Training Report (see attached).

Committees

Website

Lois Linker would like guidance as to what she can post on the website concerning classes. Phyllis Broderick responded that everything is on hold for now until restrictions start to become relaxed.

Newsletter

President Achenzie reported the deadline for the May newsletter is April 29, 2020.

Awards Banquet

Phyllis Broderick suggested that the awards banquet be cancelled this year and the awards be presented at a club meeting. Everyone was in agreement with this plan. President Achenzie will notify Judy Lasso.

Upon inquiry, Barbara Artim said she has not deposited the banquet checks as she has not received them. Phyllis Broderick stated she had included them with the last beginner class money envelope. Discussion ensued and it was determined that several things will be checked regarding the banquet checks.

Constitution and Bylaws

Lois has also agreed to be the obedience chair for the 2021 show but would like to have the club member who will take over the obedience chair position for the 2022 show work with her on the 2021 show.

Old Business

Phyllis Broderick noted that she is taking a wait and see position concerning the Connie Cleveland seminar. We should have information from the government coming out in May. Phyllis feels the seminar will fill easily and would like to put out a flyer to club members, possibly in the middle of May. After club members have a chance to register, slots can then be offered to the general public.

Carol's Beginner Class – Carol has taught one week of the beginner class. I will ask her to contact her class and see if they want to wait for the class to continue or want a discounted refund.
