He also earned his Beginner Novice in three shows with all scores in 190's.

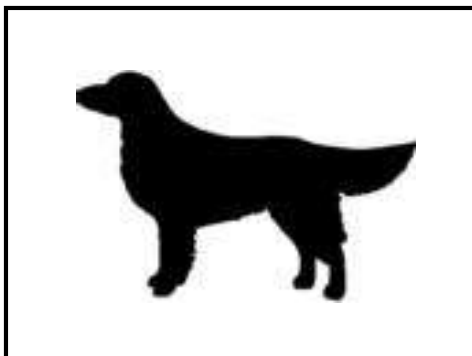
He earned two new titles at our National with placements in both Novice B- 3rd, and Beginner Novice- 4th.
