Welcome to the July 2021 newsletter. We are now in the hot weather of summer with humid and hot days and chance of thundershowers. Several of our training days on Wednesday and Thursdays have had to be cancelled because of rain and storms. Many of our start and finish dates for our training sessions have to be revamped. Be sure to check your email for updated information.

Once indoors we will be starting the prepaid classes again. With people on vacations and weather-related cancellations, it was decided for the rest of the summer to go to the pay-asyou-go schedule. Remember our club trainers are paid for their time to teach classes and the fees we pay go towards that as well as other costs such as building and park rentals, insurance and all the miscellaneous things that go with having an active club. TRAINING INFORMATION From Phyllis...

Weather permitting Wednesday club training will conclude its 6 week session July 7th. Thursday morning club training with Dusty is on a drop in basis now.
