


ADTC BARKS AND BYTES NEWSLETTER APRIL 2022

PHYLLIS'S TRAINING TIP

STEPS TO CORRECT A MISTAKE

- The moment your dog makes a mistake, tell your dog "no", "wrong" whatever word you use to let the dog know that he/she is wrong and to stop the behavior.
- Neither your voice or your body language should indicate any anger or frustration.
- When your dog makes a mistake, you should stop and abort the rest of the exercise, then show and help him correct the mistake. At this point, no reward.
- Do not give your dog a reward after you correct him. Instead give him another opportunity to respond correctly before the reward is given.
- Repeat the exercise and if the dog does it right, then praise him and then give the food reward/
- Corrections should always be unemotional and should fit your dog's temperament.
- Do not correct your dog if he/she is confused or does not understand what is expected of him. If your dog anticipates your command, he is telling you he understands what you want him to do; do not correct. Instead remind him he has to wait until given the command.



My history with dogs goes back to the mid-1980s when I got involved with the conformation ring. To date, I have taken a Doberman, a Greyhound and two German Pinschers to their AKC Champion titles and a number of group placements. In the 1990s, my wife and I became more involved with obedience and rally.

Most of my dogs have come from the same breeder who is very good at matching dogs with prospective owners. However, my current German Pinscher is an import from Italy. She is

We participate in Agility, Obedience, Rally, Scentwork, Fast Cat, CAT, Barnhunt, and Conformation. We have earned a number of titles and are currently working on our Master Agility titles, Scentwork Novice title, and Coursing Ability Advanced in CAT. In 2021 Gemma received an invitation to the Fast Cat Invitational since she was the second fastest German Pinscher in the country.

Gemma's favorite activities are Fast Cat and CAT. She loves the chase, and I love watching her smile! Rally poses the most challenges for me as a trainer. I find the signs to be quite challenging!

Because German Pinschers have minds of their own, showing them in obedience can be "interesting." I recently entered the Novice class at an obedience trial. German Pinschers aren't known for their excellence in the obedience ring, and they can truly be the class clowns. In our heel off leash pattern Gemma decided to take a break and stand ringside and watch as I performed the majority of the heeling pattern on my own! My footwork must've been impeccable because the judge told me we passed! Gemma, however, did not seem all that impressed.

I advise all new handlers to keep a sense of humor! Dogs have minds of their own, and you never know what they will do to humble you.

SPOILED DOG CAKE RECIPE

Note: If you want to make a layer cake like we did, be sure to double the recipe.

INGREDIENTS

Cake:

1 c. flour

1/2 tsp. baking soda

1/8 c. oil (we used sunflower oil)

1/4 c. peanut butter (make sure that xylitol is NOT one of the ingredients as it's toxic to dogs)

1/2 c. applesauce

1/2 c. pumpkin

1 egg

Frosting:

1/2 c. plain Greek yogurt

1/4 c. peanut butter

Assorted treats for decorating

INSTRUCTIONS

Cake:

- 1. Preheat your oven to 350 degrees F. If you're using a gas oven like we did, preheat to 325 degrees and cover the cake with foil for all but the last 15 minutes of baking time.
- 2. In a large bowl, combine the flour and baking soda.
- 3. In a separate bowl, mix together the oil, peanut butter, applesauce, and pumpkin. Mix well, and then stir in the egg until combined.
- 4. Combine the wet and dry ingredients and stir until combined.
- 5. Pour mixture into an 8" round pan (or two round pans if you doubled the recipe) that has been greased with oil.
- 6. Bake for approximately 25-30 minutes or until a fork inserted into the center comes out clean and the cake springs back when pressed lightly.
- 7. Allow the cake to cool prior to removing it from the pan.
- 8. After cooling, add frosting if desired.

ALLENTOWN DOG TRAINING CLUB GENERAL MEETING Date: March 16, 2022 MINUTES

The meeting was called to order at 6:35 p.m. by President Chuck Achenzie. President Achenzie noted that there were 25 members in attendance.
