In a few months, September, the Blue Mountain Cluster will be happening in Macungie. It is three clubs, Pocono KC, Lehigh Valley KC and Berks County KC who run this large all breed show, along with both Obedience and Rally. These clubs are breed clubs, so they are mainly interested in breed competition, and we are grateful that they offer obedience and rally. They cannot do this without volunteers to steward and Pocono does need stewards for Obedience. They are a very small club with few members. For many years they offered both Obedience and Rally on Thursday and Friday. For Rally, which means AM and PM classes each day—a total of four classes for participants to earn both legs towards titles, as well as titles and points! This year they are only offering Obedience (because of lack of volunteers) but the other two clubs are offering Obedience & Rally on Saturday and Sunday. That is a loss of four chances to earn Rally points and titles. Phyllis has offered to steward for them, but they need a few more volunteers to steward. Stewarding is a great way to learn about how trials work and the judges are very nice. 

MEMBER OF THE MONTH

I became involved in dog training with my first German Shepherd Dog, Smokey in 1977. I used my first paycheck to purchase her. I feel that most of my dogs have picked me. "Cody" was my first Therapy Dog. Shyloh, a Sable German Shepherd, that I picked up in an ice storm, was the only puppy in the litter. Bryar was handpicked by the breeder for me. When Devlyn, a coated female, was born, the breeder called me and said my puppy had arrived. Keyda was a Sable German Shepherd with a cross on her chest. Vayl was found by Bryar's breeder because I was scheduled to get a puppy from her, but her female had a false pregnancy. She went to the stud's breeder, picked out a puppy for herself, and there was Vayl, waiting for a special home. Aslyn, also from Vayl's breeder, gives me high hopes for Obedience Titles. Vayl and Aslyn are my 7th & 8th German Shepherd Dogs.

I am active in several area dog organizations. I personally started with the Therapy Dog Programs in 1994. I am an initial founder of Greater Lehigh Therapy Dogs which has now become Lehigh Valley Therapy Dogs. Currently, Vayl and I work as a team with Lehigh Valley Therapy Dogs- Member of Alliance of Therapy Dogs. I also serve as the Lehigh German Shepherd Dog Club Treasurer, and I am an active member of the Allentown Dog Training Club. As well as serving as a therapy dog, Vayl has earned her CD, THD, BN, RN, and RI. To date, Aslyn has completed her CGC, STAR Puppy, and TKN The Sky's the Limit.

Unfortunately, due to COVID-19, our therapy work is on/off. Vayl and I visit Lehigh Valley Hospital Cedar Crest and 17th Street, and we participate in the Books & Barks Reading Program at Emmaus Community Library. We have set times for most of our visits at the Hospital, but we also do visits on an "as needed" basis.

As far as favorite activities go, Vayl would rather just hang out at home. However, new puppy Aslyn keeps her on her paws. We play ball, go for walks, play ball, do training and play ball!!!

The challenge I am taking on is getting past the CD title. All of my dogs have earned at least their CD. Keyda went the farthest by achieving her CD, THD, RN, RA, RE and the AKC Achiever Dog Certificate.

Of course, dogs often keep us on our toes by making the most of a situation when we least expect it. I was training Bryar for her CD, and we entered a match at Huff's Church. Boy, was I nervous! There were no ring gates, just poles in the corners and a yellow rope strung from one pole to the other. Joanne Summers was the judge. We did okay up until we began the off-lead healing. Bryar proceeded to go under the rope, grab it, and start playing tug of war with the rope. She soon pulled down the entire ring. Friends and fans were all laughing, and it took Joanne and me a few moments to lure her to us. So much for being a novice trainer! Thanks to all my laughing friends, I have pictures to prove it.

My advice for handlers is **Listen to Your Trainers.** Starting with Alma Arnold back in the day, I have learned so much from so many. Joanne Summers has given me constant support with all my dogs. Phyllis Broderick, Linda Krasley, Diane Hilperts and Terry Papineau continue to teach me new things all the time. Listen, learn, and adapt all you learn to train your dog to the best of your ability. Make sure you "read your dog". Know when to stop and when to keep going.
