### **Precautions Regarding Canine Upper Respiratory Illness**

There are a lot of unknowns about this newest canine illness. We should all do our best to work to avoid the spread of this disease by following these basic recommendations:

- Keep your dog up to date on vaccines including but not limited to Bordetella, Parainfluenza, and Canine Influenza, and avoid direct contact with other dogs.
- If your dog has been exposed to a dog with an upper respiratory illness, but is showing no symptoms, it is recommended you quarantine your dog for a minimum of 2 weeks. Do not take it to any areas where other dogs will be.
- If your dog has been exposed to a dog with an upper respiratory illness, and is showing symptoms, it is recommended you quarantine your dog for a minimum of 4 weeks after all symptoms have passed. Do not take it to any areas where other dogs will be.
- Absolutely do not take your dog to any events if it is showing any signs of respiratory illness such as coughing, sneezing, wheezing, any nasal discharge, lack of energy, or difficulty breathing.
- Avoid sharing water and food bowls among dogs. Dog bowls should be washed regularly.
- Regularly wash or sanitize your hands, especially after handling dogs.
- If in doubt, speak to your veterinarian.

While judging guidelines recommend that judges ask the exhibitor to display the oral exam, during this time and out of an abundance of caution, judges are expected to have the exhibitor display the oral exam and may personally examine the mouth ONLY if absolutely necessary. Where applicable, judges must conduct thumb exams.

If necessary to personally examine the mouth, the judge **MUST sanitize their hands after examining the dog,** and as a general practice, are strongly encouraged to sanitize their hands after examining each entry. Re-examining of dogs should be minimized.

Clubs hosting conformation events should provide hand sanitizer/wipes for judges and stewards to use between dogs. Equipment used to measure and/or weigh dogs should be sanitized before and after each use.

Responsible actions by exhibitors, judges, and clubs are necessary to minimize any risks to our dogs. We thank everyone for their thoughtful cooperation and diligence in taking these extra measures.

Here is a story by Judy Skorup written to let us know, NEVER GIVE UP!! Judy had a goal when she got Emma as a Great Pyrennes puppy, a breed not known for doing well in either Obedience and Rally. Her goal was to earn a RALLY CHAMPIONSHIP TITLE—RACH. In the process, Emma also earned many other titles, some for which her breed is noted. But this title, Judy will tell us, was the one she is most proud of and hardest to earn. We noted this in the November issue but this is the story of Judy and Emma's journey.

## Mission Completed: Emma Has Her RACH!

Success: Emma Earned the RACH!

When I started training my first Great Pyrenees in Obedience and later in Rally, long time Pyr owners told me Pyrs don't do obedience, or they can't be taught to do obedience. That was in the late 1990's. Thankfully, a Great Pyrenees owner and trainer named Jane Gill told me that it was possible and gave me numerous tips to get me started in Obedience. I still train with her suggested 3-4 different types of yummy treats, and it works!

Fast forward to the arrival of Rally: Pyr Merlin earned a RA, Pyr Bonnie earned her RE and retired breed Champion Pyr Keenai earned his RN, then retired. For Keenai, off lead activities did not work — he just stood, stacked, and grinned at the judge!

Emma arrived in 2016, demonstrating a lot of energy plus a willingness to do everything and we were off and running! She quickly earned her BN, RN, CD, RI, RA, and RE. Emma's first Rally instructor, Jeanne Anne Polichetti, owned several Pyrs who earned multiple Rally titles, including the first Pyr to earn a RACH. A little more time and Emma had an RAE. Then came the first RM.

Decision time: Should we test for the RACH title? Yes. It would take longer for Emma than other dogs as testing three times in one day was enough, so never two trials in one day nor testing back-to-back days. Earning the 20 triple Qs was not especially hard and earning the required 150 points in the Advanced and Excellent classes was easy, but the Master points were a challenge. Emma often earned Master scores in the upper 80's, good effort, but no points. Noisy locations with multiple rings were very distracting for a livestock guardian dog, so we attended more distant smaller trials with fewer rings.

The Master points kept increasing and we earned several more Master titles. When the Master point count reached 125, I suspected we would finish the RACH in 2023. However, at 7 yrs. old, Emma was bored and tired of Master Rally courses so our progress slowed. We entered two trials at Lower Camden County Dog Training Club in Lindenwold, NJ on October 22, needing 6 more Master points for the title. I thought we would probably earn 5 points in one of the two trials, meaning I would need to find and enter another Rally trial in November or December to earn the last point.

Of course, there is always at least one sign in every course that Emma does not want to do, even though she can do it easily when she wishes. There it was: #307, the Halt, Send to Cone, and Sit. She sat and looked at it. At first, no command nor hand signal was obeyed. Then, she slowly got up and went straight to the cone, sat and grinned at me. Happy verbal praise to Emma and the rest of the course flowed slowly, but nicely. We finished to a round of applause from the spectators at the trial and left the ring.

I knew we had qualified but expected to lose points for crooked sits and slow responses. Several exhibitors commented to me about how hard it is to work a non-traditional breed off lead in Rally and Obedience and how they could not do what I had done. They would not have the patience.

## \*EMMA\* (Continued)

I looked at our score – a 95/100. I did check the rule book to be sure. Reality hit – we had just earned our last Master points, our seventh Rally Master title and the RACH! The huge white, golden yellow and black RACH rosette was presented after the class received ribbons. A couple of Obedience club members took photos of Emma and me with her rosettes.

Our goal has been reached! It may take more time for some breeds, but with planning, patience, persistence, and a strong bond with your dog, earning a RACH is possible.

Emma and I are very appreciative of our friends, club members and instructors who encouraged and supported us, gave us training tips and Rally instruction to earn this title. Thank you to instructor Jeanne Anne Polichetti, followed by Judge Linda Krasley, and instructors Sharon Wendelgass and most recently, Carol Hahn. Emma is only the second Great Pyrenees to earn the RACH title.

Emma is now retired from Rally and will focus on other activities she enjoys: Nose work, Therapy Dog visits and running in Fast CAT races.


