Judges are not required to wait for dogs. The owner or handler is responsible for having
the dog at ringside when its number is called.

To request an in-season refund, contact the ADTC Trial Secretary.

All dogs present must be on leash except when being judged in the ring.

Only entered dogs are permitted inside the trial.
